### Objectives

Following the debates of the first Round Table organised in Bucharest 8 -10 March 2022, the objective of the Brussels meeting - bringing together high representatives of judicial training schools from both shores of the Mediterranean together with representatives of EJTN, European and International training institutes - is two folded:

1. To identify best practices and common standards for the development of curricula on international judicial cooperation in criminal matters between criminal justice practitioners from EU and SPCs.

2. To explore the possibility of increasing the synergies, coordination and exchanges with Euro-Arab Judicial Training Network (EAJTN) together with its visibility; to reflect on the coordination EMJ Programme - EAJTN and the EAJTN role in the next EMJ phase.
