Joint cross-border meeting, consultations, exchange of experience and operational challenges on combating trafficking in human beings and migrant smuggling

10 - 11 May 2023, Eurojust - The Hague

1. Justification

One of the EuroMed Justice Programme key objective consist in organising regional meetings when cross-border cases involving SPCs are identified - EMJ Programme Component 4.

The Joint meeting organized on 10 – 11 May 2023 at Eurojust is implementing the <u>Action Plans</u> - Action Plan A. Countering the trafficking in human beings and smuggling of migrants within the cross-Mediterranean region, Strategic Goal 2. Operational cooperation; Actions 2.1, 2.2. designed by CrimEx and endorsed by the 3rd PG Forum in November 2021.

2. Background

EMJ facilitates the dialogue and operational contacts among EMJ stakeholders for the implementation of the actions 2.1 (to explore the possibility to set up operational groups on countering THB corresponding to the geographically criminal realities observed on the ground) and 2.2 (to jointly debate and identify practical solutions, facilitate first contact, expedite judicial cooperation).

Considering the importance of creating and maintaining connections between the criminal justice authorities from SPCs specialised in the fight against THB and smuggling of migrants with their counterparts from EU MS,

EuroMed Justice Programme is organizing a joint meeting of high-level criminal justice and law enforcement officials specialised in countering THB and migrants smuggling from Israel, Jordan and Netherlands who together with representatives of Eurojust College Working Group on anti-trafficking and JITs Secretariat will exchange their professional experience in **The Hague at Eurojust on 10-11 May 2023**.

3. Objectives

Bringing together high – level criminal justice practitioners from South Partner Countries and European Union Member States together with representatives of Eurojust and EuroMed Justice to exchange experience, operational challenges and best practices on preventing, investigating, prosecuting and adjudicating THB and migrant smuggling offences.
