#### **Background information**

#### **EuroMed Justice Programme**

EuroMed Justice (EMJ) is a capacity-building program designed to develop a sustainable cross-regional mechanism of judicial cooperation in criminal matters between EU Member States (EU MS), the South Partner Countries (SPCs) — Algeria, Egypt, Israel, Jordan, Lebanon, Libya, Morocco, Palestine<sup>1</sup> and Tunisia — and EU JHA Agencies. The main purpose of the programme is to strengthen international cooperation in criminal matters between SPCs and EU MSs and EU JHA Agencies.

#### The Conference

EuroMed Justice (EMJ) Programme and the Academy of European Law (ERA) will co-organise on 15-16 May 2023, at ERA's headquters in Trier, Germany, an international conference on joint investigations. The conference will bring together prosecutors and judges from South Partner Countries (SPCs)² and European Union Member States (EU MSs) together with representatives of EU Agencies and International Organisations to discuss and share knowledge and practices on how to make use of joint investigations, parallel investigations and spontaneous exchange of information, to better address cross-border crime, especially in the context of cross-Mediterranean cooperation in criminal matters.

EuroMed Justice will present for the first time the new practical tool on joint investigations, parallel investigations and spontaneous exchange of information developed with the support of practioners from SPCs and EU MSs and experts on criminal justice.

Eurojust and the JITs Network Secretariat will share experience and knowledge on the establishment of joint investigation teams (JITs) and their functioning and on the specifics of JITs including EU MSs and third countries. The Guidelines on JITs involving third countries jointly prepared by Eurojust and the JITs Network Secretariat wil also be presented.

## **Objectives of the conference**

The main objective of the conference is to strengthen the capacity of the criminal justice authorities of the EU MSs and SPCs to fight serious and organized crime through efficient and effective cross-border judicial cooperation, with the use of joint investigations, joint investigation teams, parallel investigations and spontaneous exchange of information.
